RE: Retirement of Pole #30018 on the South Tomahawk Federal #1 Well Site


Dear Mr. Webb:

As you are aware one of your electric poles is located on a Jalapeno Corporation's well site. In the process of abandoning and reclaiming this location, the Bureau of Land Management had informed us that the electric pole needed to be removed. Over the last few months I have talked to Dusty Niece, and more recently with you, regarding the removal of this pole. It is my understanding from these conversations that removal of this pole is not a high priority for the Roosevelt County Electric Cooperative as your primary concern is to service the energy needs of your customers and the retiring of an electric pole will be dealt with after your commitments to your customers have been met. With this in mind, I understand that the electric pole will be removed when time and equipment becomes available.
