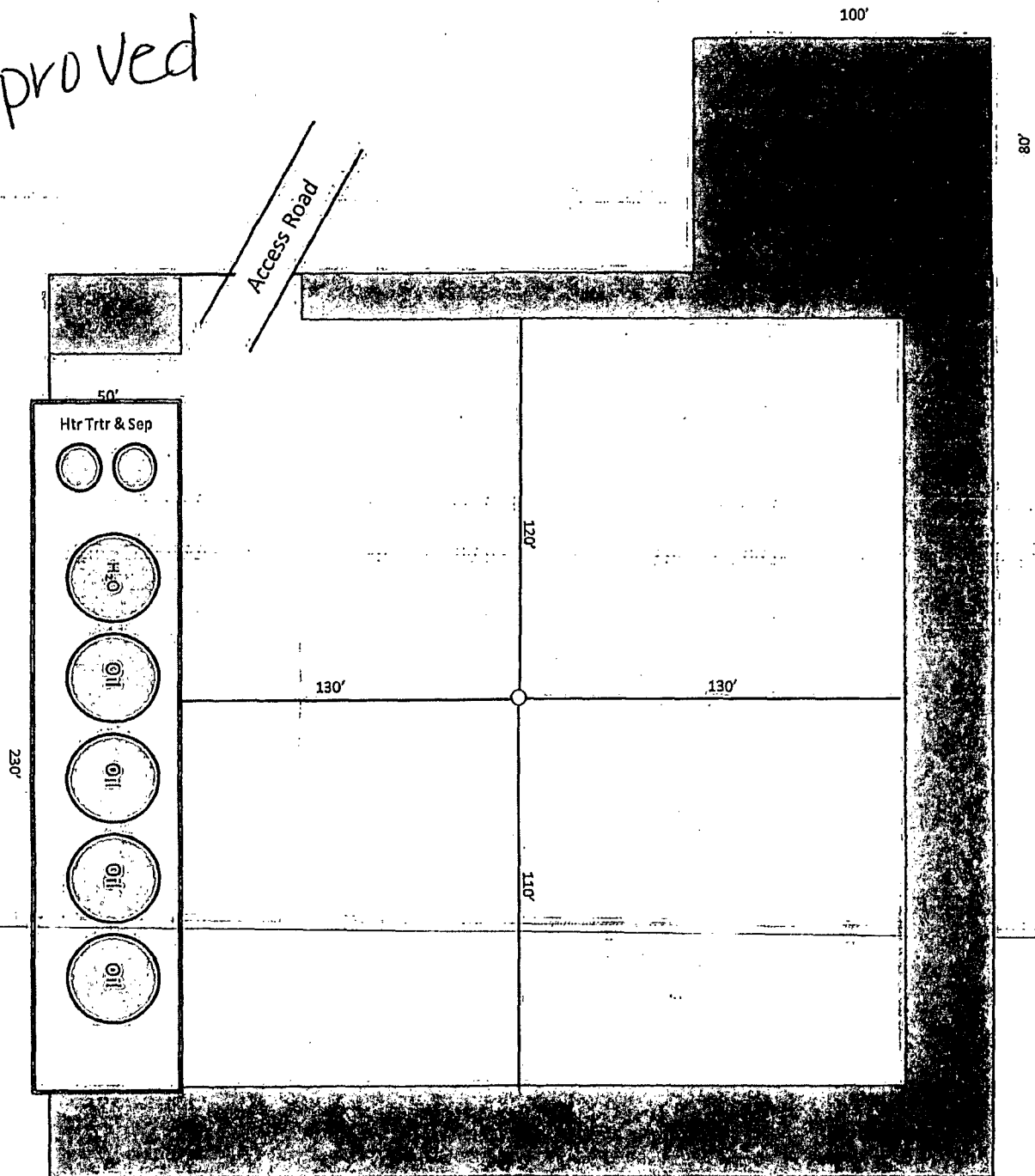
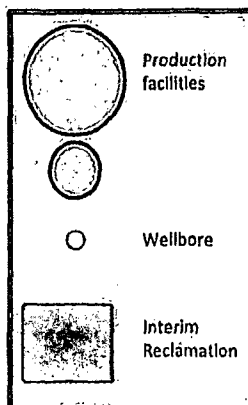


Exhibit D-1

Lea County, NM



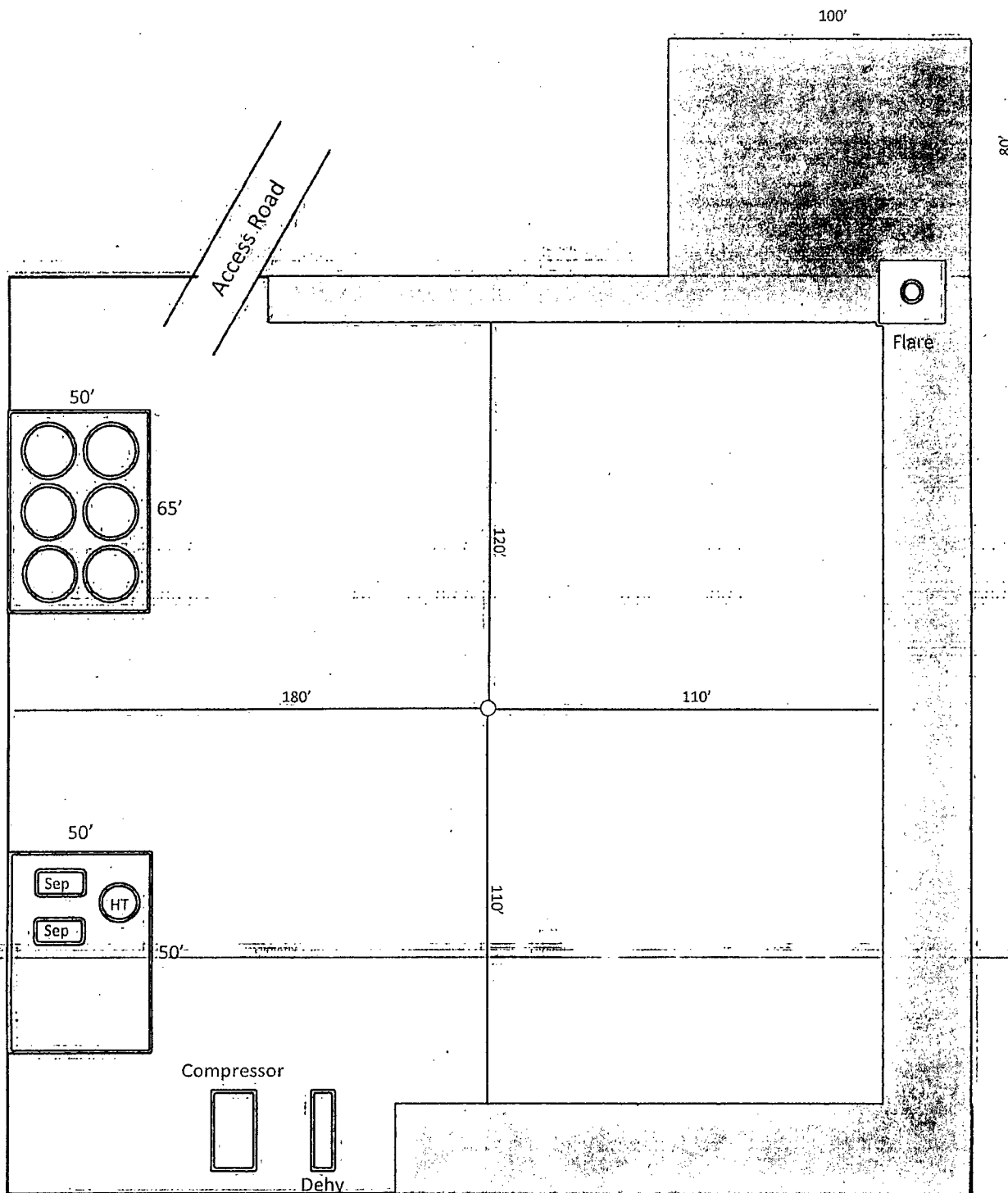
