Drilled cement from 6050 ft to 6437 ft, fell out. Tagged up again at 6784 ft. Drilled 3 ft to 6787 ft to ensure it was solid cement. According to well records the cement plug should have been from 6515 ft to 6662 ft. Based on that information, original approved plan was to drill to 6550 ft and set 5-1/2 inch L-80 casing and cement against the cement plug. As there is no cement plug at 6550 ft but at 6787, we ask permission to set the casing at 6787 ft. The new depth is in same formation and will not result in any change of injection interval. They will remain as per order SWD-1301.

Received verbal approval from Ed Fernandez on 1/25/13 to run 5-1/2 inch L-80 casing to 6787 ft instead of 6550 ft to have a hard cement plug to set casing and cement against.
