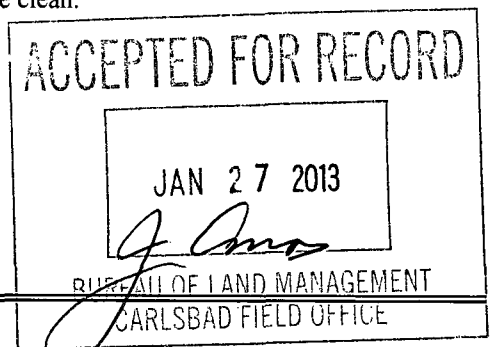

11/30/12 Drilled out 10 of 11 CFP's. Left CFP covering DFIT perfs @ 15453'. Circulate clean.

12/7/12 to 12/8/12 Set 2 7/8" 6.5# L-80 tbg & pkr @ 10309'. Test annulus to 1500#.

12/9/12 Began flowing back & testing.
