The approved location was to be downsized by 70' on the north and 70' on west, but due to wellbore placement we only have 49' to anchors on the north and 69' to anchors on the west. The extra pockets will be removed as well.

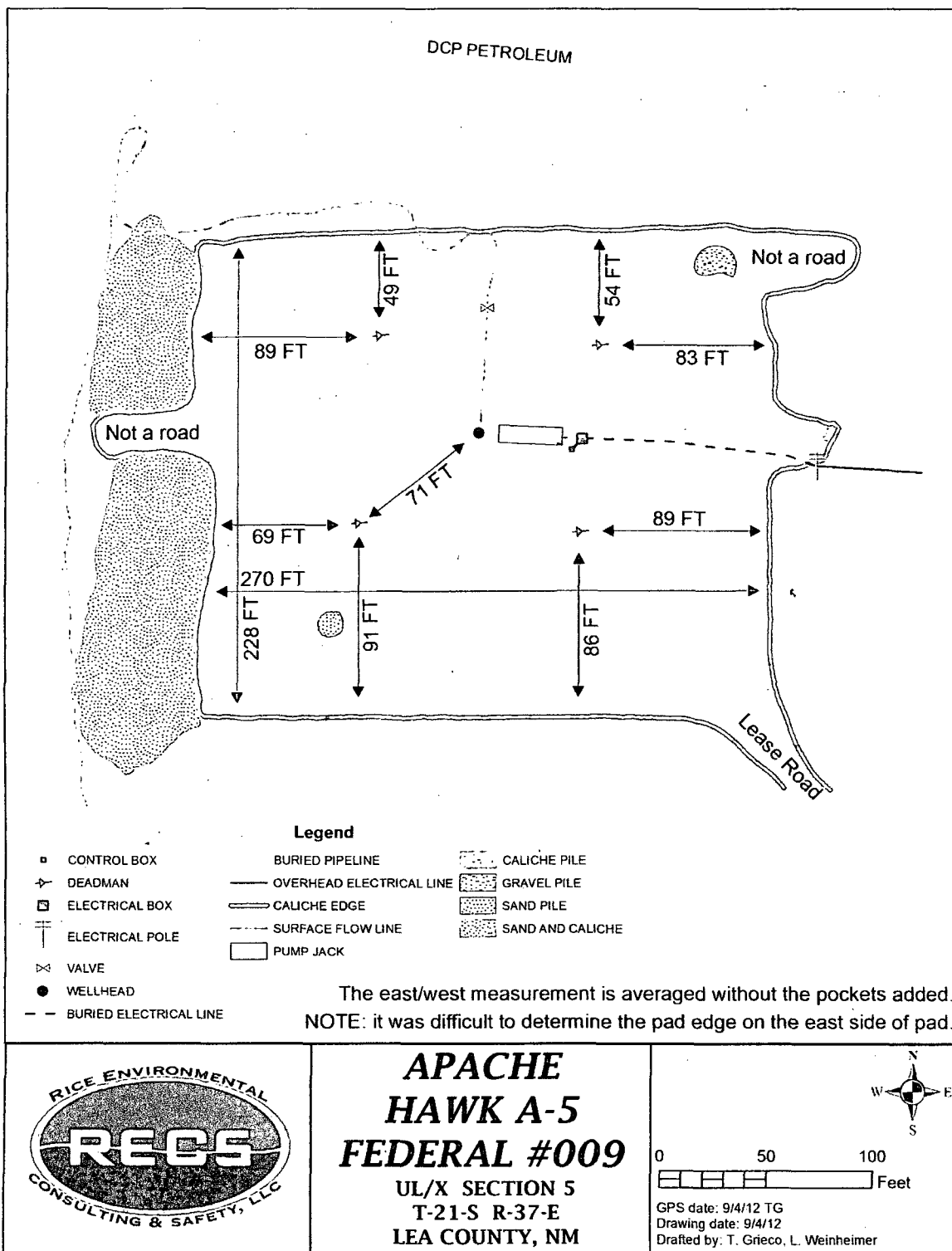

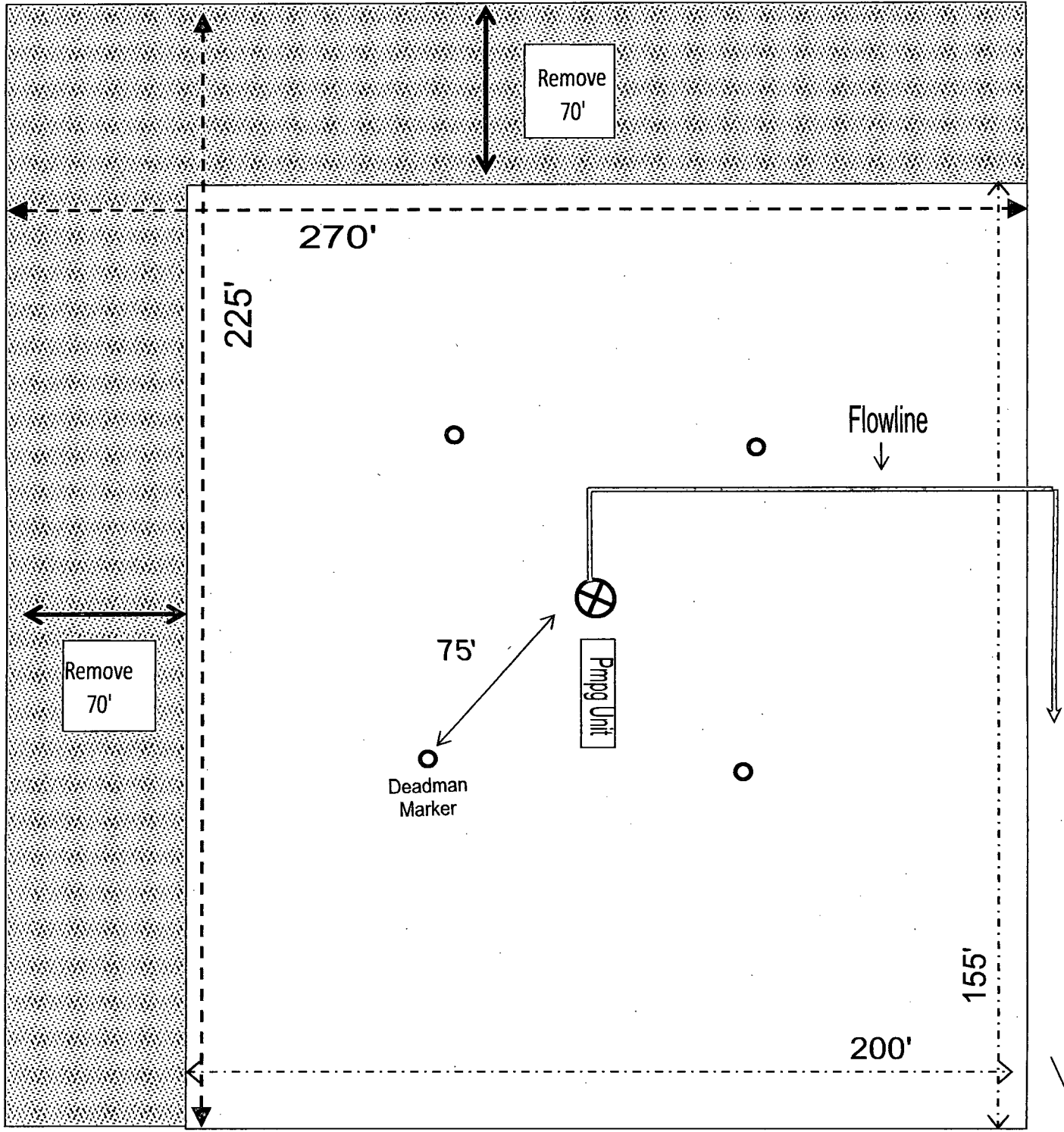

James,

Attached you will find the Apache Hawk A-5 Federal #009 pad measurements along with the reclamation layout that was approved in the APD. This wellbore was offset from the original drawing, the pad construction is almost accurate. We are currently waiting to get approval from the BLM to re-enter the wellbore and complete another zone. Once we recomplete, then at that time we can downsize the location. Apache spudded the well on 06/08/2012 and the well was completed on or around 08/11/12. We may need an extension on the downsize depending on when we get the other zone taken care of. We started the remediation this morning on the drilling mess, but will not downsize yet if you allow us to wait until the completion of the additional zone.

The original reclamation plat that was approved with the APD shows 70' from the north and 70' from the west side. We have approximately 49-54' on the north from the anchors and 69' to 89' on the west. What Apache would like to propose is to downsize the north by 20' and the west by 50'. We will need the south side for the pulling unit and the east side for other production equipment that will be needed to do future work-overs, etc. The northwest corner I will take out the leg and square it up to the location. The green pile you see on the west has a lot of caliche mixed in with the topsoil, so not sure if you want to use that as topsoil or not. Please communicate with me what you would like done on this location.
