Apache Corporation would like to request a varience from the approved interim reclamation. The IR Plat suggested that the location was to be 270'x225' but actual size is 270x243, the downsize would end up with the measurements of 200'x155', there was also an additional road installed during the drilling process for better access, therefore it will need to be taken out as well. Approved APD downsize was 70' off of the north side and 70' off the east. Due to the wellbore placement and the anchors being 38' from the east, we will need to downsize the east by only 16'. Due to the additional road we would like to downsize the west side, taking out the road and additional footage to 63'.

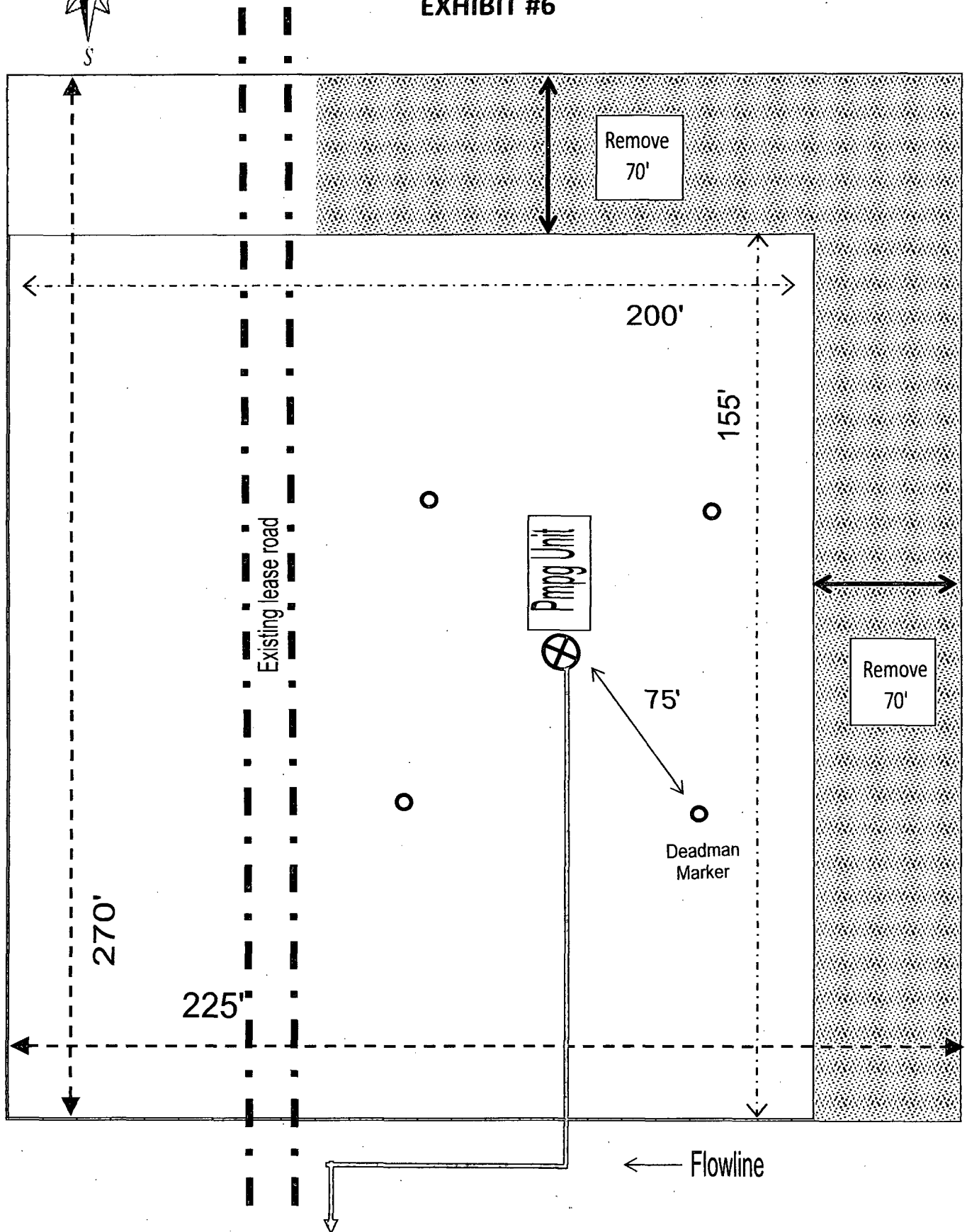

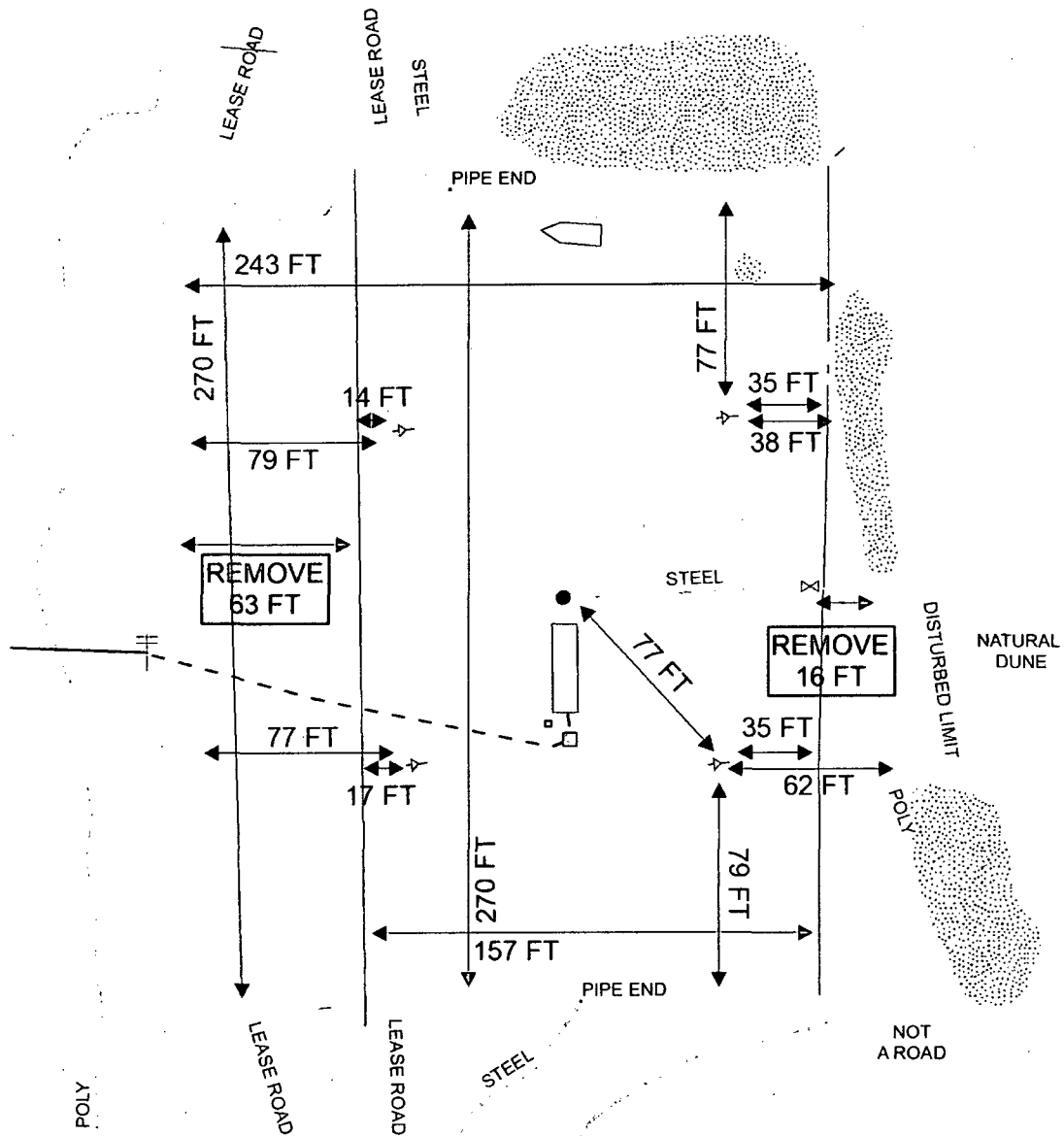
