Pump 1095 sx (482bbls) of class C lead cmt & 310 sx (74bbls) of class C tail cmt. Disp & bump plug & circ w/ 180 bbls to surf. Drilled to 9220' w/ 8 3/4" drill bit. RIH w/ 214 jts, 7", 29#, P-110 set @ 9205' & DVT @ 6896'. Pre flush w/ 30 bbls FW. Pumped 1st stage of cmt as follows: 101 sx (48 bbls) of class C lead cmt & 151 sx(38bbls) of class C tail cmt. Disp w/ 340 bbls of FW & bump plug @ 1030#. Open DVT. Pumped 2nd stage as follows: 230 sx (106 bbls) of class C lead cmt. Disp & bump plug & TOC 3900'. Drilled to 14,446' w/ 6 1/8" bit. RIH w/ 126 jts prod csg, 28 frac sleeves, & 27 pkrs, 4 1/2", 11.6#, P-110 csg set @14,286' & TOL @ 8654'. ND BOP NU WH. RDMO.
