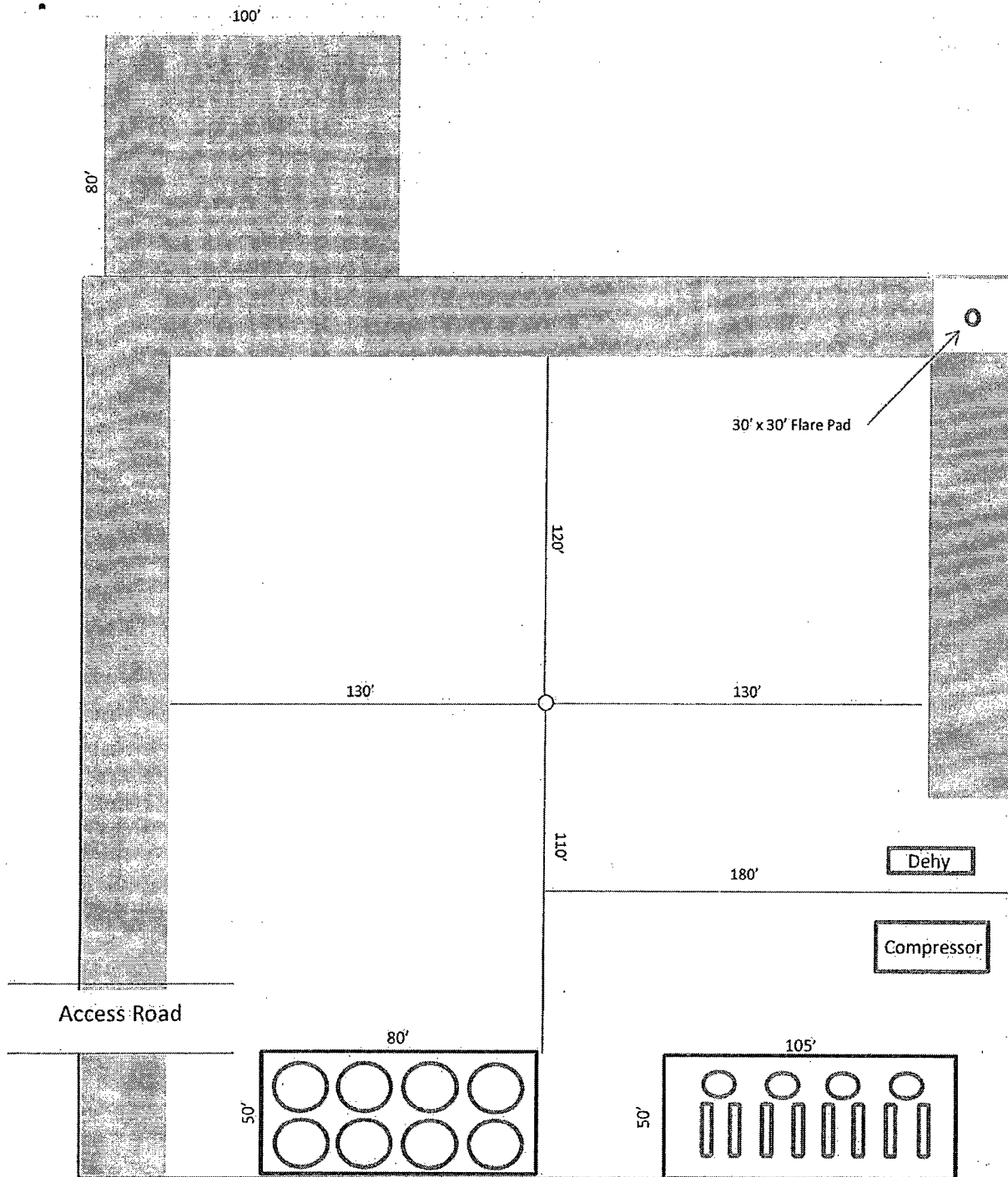


Exhibit D-1
