Comments on Inspection: Well sign at well needs to be replaced. Current rules require that sign contains Operator, Lease, Well number, UL, Section, Township, Range, Footages, and API number. No well sign at battery.
NEED TO REPLACE WELL SIGN AT WELL AND INSTALL NEW SIGN AT TANK SHOWING LEGALS AND EMERGENCY CONTACT NUMBER.

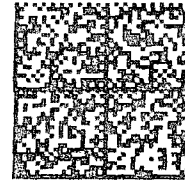
