RIH w/ 216 jts, 7", 29#, P-110 set @ 9129'. Pre-flush w/ 30 bbls FW. Pumped 430 sx (294 bbls) of class H lead cmt & 130 sx (37 bbls) of class H tail cmt. Disp w/ 348 bbls, bump plug & circ 68 bbls to surf. Drilled to 13,592' w/ 6 1/8" bit. RIH w/ 99 jts, 28 port's, 4 1/2", 11.6#, P-110 csg set @ 13,580' & TOL @ 8761'. ND BOP NU WH. RDMO.
