13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. 1. Pressure test tubing-by-casing annulus.
2. Kill well, if necessary, and ND well head, NU BOPE, and POOH w/tubing and packer.
3. PU workstring and RIH to TD w/ bit, 1-DC, gauge string mill, 3-DC's. Circulate clean & POOH.
4. RIH with production packer w/plug in place if necessary and recover kill fluid. POOH, ND BOPE, install CO2 tubinghead, and NU BOPE.
5. Run 2-3/8", 4.7#, J-55, 8rd EUE Seal Lube IPC production tubing and 1/4" cap strings. RIH very slowly due to limited clearance. Pump through each 1/4" string while on the spool and record pump pressure. Pump through each string again every 10 joints or so while running in hole and record pump pressure. Pull out and check each string if pump pressure indicates either 1/4" was damaged while RIH.
6. Circulate hole with inhibited freshwater packer fluid and test casing. Space out, land tubing, and test cap strings. ND BOPE and install top flange, nipple, valve, and flowtee.
7. Pull plug, connect water and CO2 gas lift lines and place well on production.
