Once releasing the TAC, Chevron was able to pull the tubing out of the hole with no problems. The well was a low producer and is currently being evaluated for another project in the field. Therefore Chevron would like to cancel our request to P&A this wellbore.

A request to temporarily abandon the wellbore is following this request.
