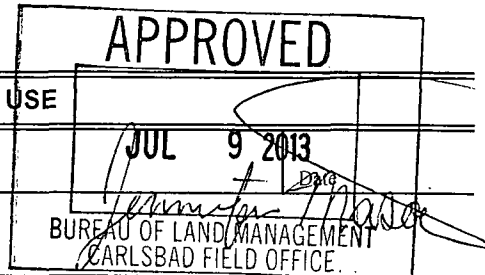

The North Bell Lake Federal #3 is currently shut-in due to continuing purchaser/pipeline issues. Repeated pipeline shut-ins have resulted in a liquid loading condition which cannot be overcome without a continuous lift mechanism in place. Gas lift valves will be installed in the well once an appropriate gas purchase agreement can be negotiated with a nearby pipeline company. The anticipated time frame to have a working gas lift installation in place is several weeks.

Approved to Shut well in, well must be back online by 9/9/2013.
