6/21/2013 Move in rig up and lay down rods.
6/24/2013 Install BOP and POOH with 175 jts 2 3/8" tubing. Parted in the body. RIH and caught fish at 5540'. POOH and laid down 51 jts below overshot.
6/25/2013 RIH with overshot and caught fish at 7170'. Called Rotary Wireline. Ran free point and cut pipe above anchor at 10230'. POOH with tubing and laid down 50 jts below overshot. SION
6/26/2013 Laid down another 47 jts and cut off. RIH and tagged fish at 10230' and spotted 35 sx class "H" cement. WOC and tagged at 9957'. POOH to 7570' and SION.
6/27/2013 Closed BOP and tested casing to 250#. Bled off to 0 in 1 1/2 minutes. Called OCD. POOH with tubing and perforated at 7520'. RIH with packer and squeezed perfs with 35 sx class "H" cement. POOH above the liner at 4536' and SION.
6/28/2013 RIH and tagged at 6792'. Called OCD. POOH to 6188' set packer and WOC and tagged at 6027'. POOH to 5428' and spotted 35 sx class C. POOH above the liner and SION.
7/1/2013 Tubing stuck. Casing and tubing were on a vacuum. Called OCD. RIH with wireline down tubing and tagged at 947'. RIH with wireline between 8 5/8" casing and tubing and set down at 1030'. Called OCD. RIH with wireline and backed off tubing at 914'. Laid down pipe in the derrick and spotted 120 sx cement on fish at 914'. POOH and SION.
7/2/2013 RIH and tagged at 497'. Pumped cement to surface with 130 sx class C cement. Rigged down, installed marker and cut off anchors.
