## Gentlemen:

Per Oil Conservation Division, Hobbs office has reviewed paperwork sent in for these wells listed above. This paperwork cannot be approved, because V-F is out of compliance with your Inactive well list. Per OCD Rule 19.15.25.8 an operator that has 4 to 100 wells may have 2 wells on their Inactive well list. V-F Petroleum has 75 wells and 3 are on the Inactive well list.

OCD is asking V-F Petroleum to Shut-In the Angel 13 State #2 because you have been producing since June 2012 without an approved C-104. C-104 that was sent in at that time was DENIED for the same reason, the Inactive well list that is still out of compliance.

The Cabot B State #1 completion paperwork and form C-104, state that you have put this well on production in May 2013 after recompleting. OCD again is asking V-F Petroleum to Shut-in this well, because V-F is out of compliance with the Inactive well list.

The OCD Hobbs office has also received forms C-101 and C-102 for the Getty 1 State #1. Your intent states that you want to Re-entry this well and put it on as a disposal. At this time OCD cannot approve this C-101. You are not to start this Re-entry because of being out of compliance with the Inactive well list and you do not have an approved disposal order for this well.
