13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Apache intends to permanently plug off the Paddock with a CIBP @ 5170' and pump and tag 35' of cement on top of the CIBP. The Grayburg will be RTP, leaving the San Andres and Glorieta open for future testing due to the gas shows seen while drilling. From 5050'-60' we saw kicks of 150 units (bgg = 25 u) and from 5100'-30' in the Glorieta, we recorded 75-120 unit shows. These are not overwhelming shows to justify going after just yet, but would like to have the option of testing them after the Grayburg depletes and prior to P&A of the entire wellbore. The DHC for the Grayburg and Paddock can be cancelled.
