CIRCULATED 289 SX CEMENT AT SURFACE. WAITED ON CEMENT 8 HOURS. NIPPLED UP CASING HEAD AND BOP EQUIPMENT. SUCCESSFULLY TESTED BOP EQUIPMENT. DRILLED 12 1/4" HOLE TO 5449'. SET 9 5/8", 40#, J-55 AND N-80 INTERMEDIATE CASING (BOTTOM 1575' IS N-80) AND CEMENTED WITH 350 SX 35/65/4 POZ CLASS "C" WITH ADDITIVES AND 200 SX CLASS "C" NEAT THRU SHOE AT 5449'. CIRCULATED 250 SX CEMENT TO SURFACE THRU DV TOOL AT 3823'. CEMENTED SECOND STAGE THRU DV TOOL AT 3823' WITH 1,675 SX 35/65/4 POZ CLASS "C" WITH ADDITIVES AND 661 SX CLASS "C" NEAT. CIRCULATED 237 SX CEMENT TO SURFACE. NIPPLED UP "B" SECTION CASING HEAD AND BOP EQUIPMENT. SUCCESSFULLY TESTED BOP EQUIPMENT. DRILLING AHEAD WITH 8 3/4" BIT.

DRILLED 8 3/4" HOLE TO 11,230'. RAN OPEN HOLE LOGS AND GYROSCOPIC DIRECTION SURVEY. PLUGGED BACK THE 8 3/4" HOLE TO 10,170' WITH 520 SX CLASS "H" CEMENT WITH ADDITIVES. DRILLED CEMENT 10,170'-10,445'. SET WHIPSTOCK AND SIDE-TRACKED 8 3/4" HOLE AT 10,428'. DRILLED 8 3/4" HORIZONTAL LATERAL HOLE TO 13,744'. CURRENTLY DRILLING AHEAD.
