Approximately 16 bbls of produced water was released from equipment malfunction (nipple separated from pipe). All released fluids were contained within the pad site. EOG propose to delineate the impacted area, vertically and horizontally by collecting soil samples and having them analyzed for TPH, BTEX, and Chlorides. The impacted area will be excavated, stockpiled on poly-plastic, and transported to Sundance disposal facility. Clean material will be backfilled within the excavated area to normal grade.
