13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Approximately 3 bbls of total fluid, consisting of 2.5 bbls of production water and 0.5 bbl of oil. Approximately 2 bbls of produced water and .5bbls of oil were recovered. The release affected a 15 foot by 20 foot area. Soil samples were collected within the impacted area at two locations (SP1 & SP2) from the surface and approx. 1 foot below ground surface (bgs). Soil samples were analyzed for Chlorides. Elevated levels of Chlorides were present within both surface soil samples, but decreased below cleanup action levels at 1 foot bgs. EOG proposes to excavate the 15' x 20' impacted area to 1 foot bgs. All excavated impacted soil will be transported off site to an approved disposal facility. Please find the field notes with analytical results attached to this subsequent report.
