CIMAREX ENERGY COMPANY IS REQUESTING TO CONSTRUCT TWO, BURIED 4" FLEX PIPE PRODUCTION PIPELINES (250 PSI). THE LINES WILL TAKE THE PRODUCTION FROM THE TRISTE DRAW 30 FEDERAL #3H (SW/4SE/4 SEC. 30) & #2H (SE/4SW/4 SEC. 30) WELLS, WEST, FOLLOWING THE ACCESS ROAD, TO THE BATTERY AT THE TRISTE DRAW 30 FEDERAL #1 (SW/4SW/4 SECTION 30). THE PRODUCTION LINE FROM THE #3H WILL BE 1971.2 FT. AND THE #2H WILL BE 985.6 FT. THE THIRD LINE WILL BE A BURIED, 4" FLEX, GAS LIFT PIPELINE (900 PSI) TO RUN 1971.2 FT. FROM THE BATTERY AT THE TRISTE DRAW 30 FED #1, EAST, FOLLOWING THE ACCESS ROAD, TO THE #2 AND #3 WELLS, TO PROVIDE POWER TO OPERATE THE WELLS.

THE PROPOSED PROJECT IS ALL WITHIN THE SAME LEASE OF NM-031224 AND THE ARCHAEOLOGICAL CLEARED AREA FOR THE ACCESS ROAD SYSTEM. CONSTRUCTION WILL BEGIN UPON APPROVAL AND WILL TAKE ABOUT 15 DAYS TO COMPLETE.

THE LAND OWNER IN THE SW/4 OF SECTION 30 IS BRININSTOOL XL RANCH (CHRIS BRININSTOOL) WHOM CIMAREX ENERGY COMPANY HAS AN AGREEMENT IN PLACE FOR THE TRISTE DRAW FEDERAL WELLS, ROADS, AND UTILITY LINES.

THE TOTAL LENGTH OF THE 3 PIPELINES IN SECTION 30 WILL BE 4,928 FT. (0.93 MI.) OR 3.39 ACRES OF DISTURBANCE.

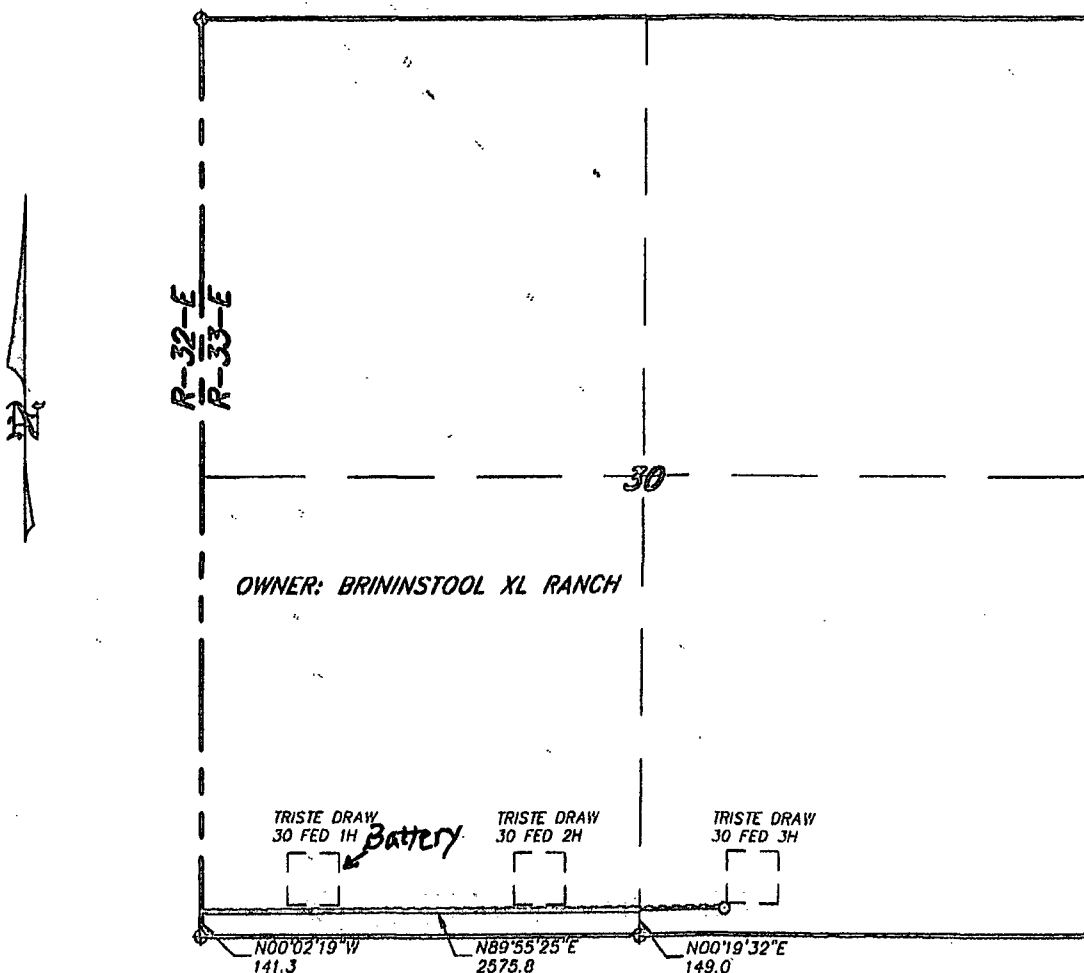

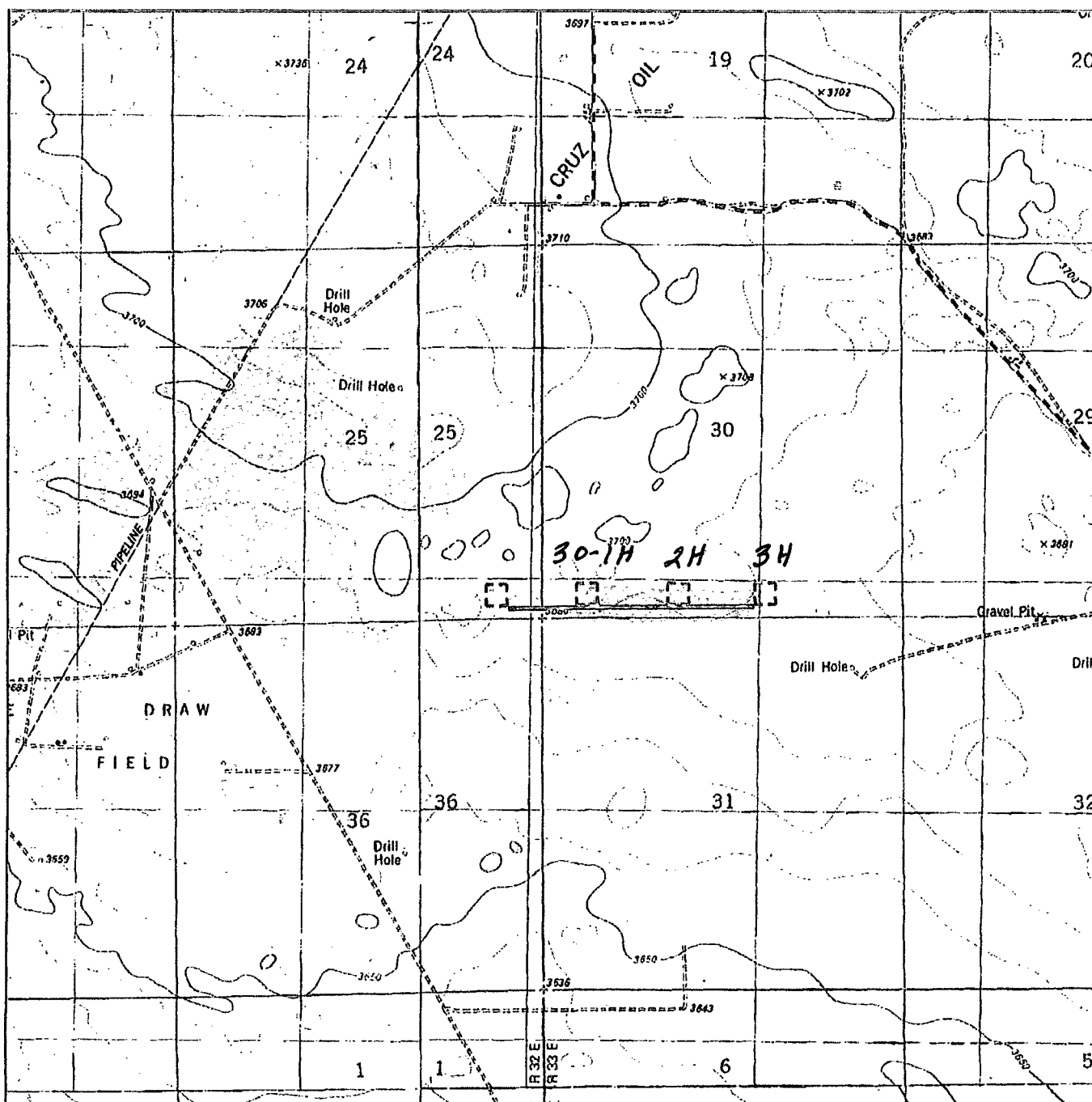
