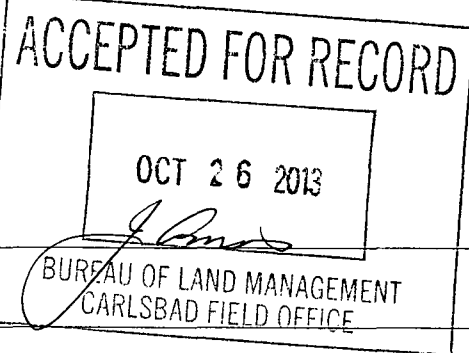

Frac totals: 80,000 gals 15% HCL, 2,648K gals slick wtr, 1797K# 100 mesh sand, 1073K # 20/40 white sand, 4064K# 30/50 white sand. Did Braden head squeeze to raise TOC w/lead 250 sx CI C, Tail with 250 sx CI C. Displace with 59 bbls FW. Ran CBL. Found new TOC to be at 1220'. RIH with 2-7/8" tubing. Land tubing @ 9165'. Turn well over to production.
