08/11-09/14: Drill 8-3/4" hole to 15,220'. Run 5-1/2" 17# new P-110 LTC w/Baker Optisleeves to 15,220'. Cmt w/805sx Tued Lite lead, 1250sx Versacem tail. WOC. Cut csg, NU tbg head, test. Release rig 9/14/2013 @ 10:30.
