

2. Run OH whipstock with 1000' of 2-7/8" tubing below whipstock. Whipstock set approximately 9,100' with EOT approximately 10,100'. Mix and pump 460 sx of Class H Cement @ 15.6 ppg @ 1.2 yield through end of tubing up to whipstock.
