
Cimarex is proposing a 380' X 320' drilling pad in order to accommodate the rig requirements.

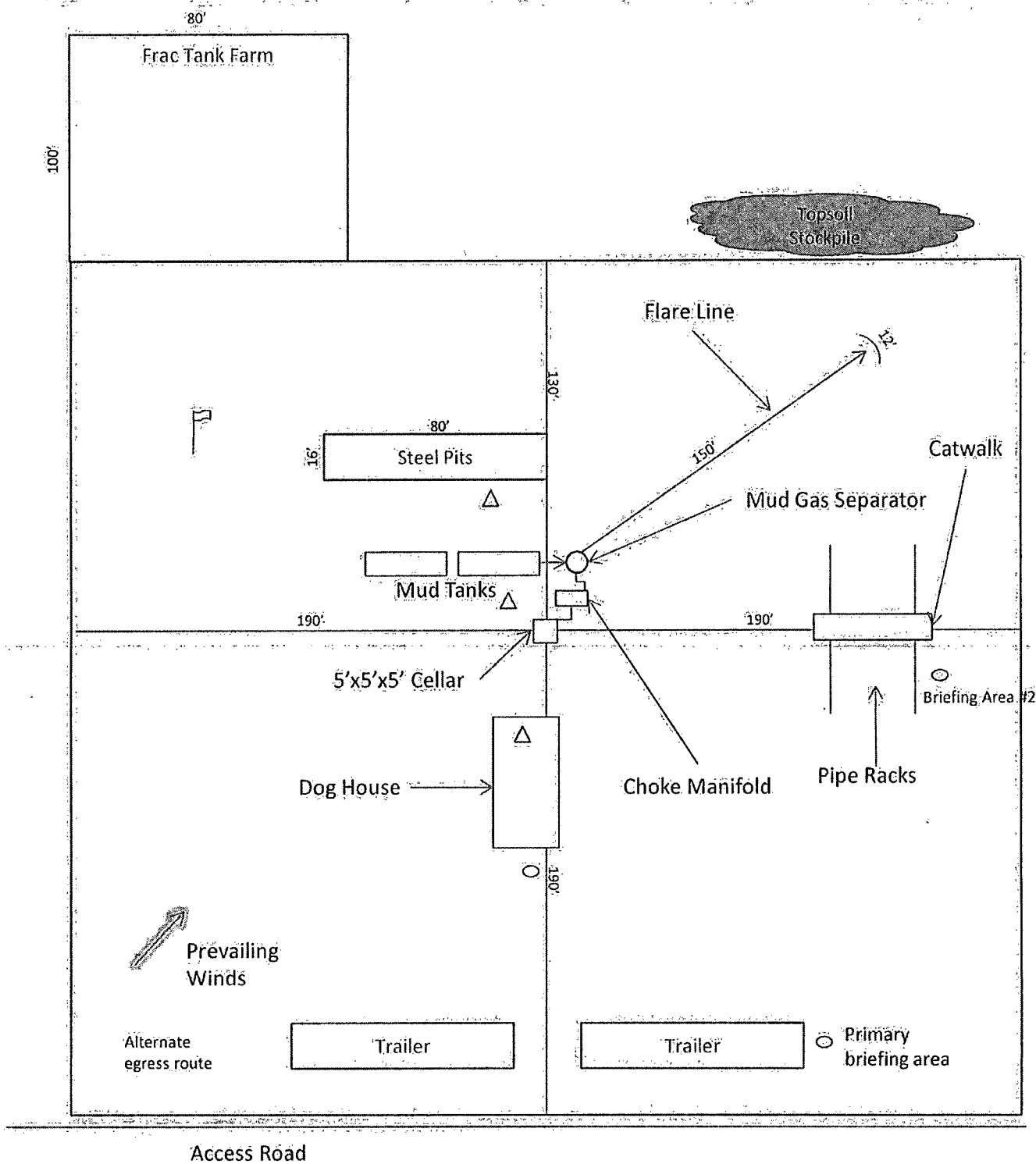


Exhibit D – Rig Diagram
