

This well's recorded activity has been inactive/shut-in for more than 30 days without authorization. An inactive/shut-in well bore is a non-producing completion that is capable of "beneficial use" i.e. production in **paying quantities** or of service use.

Determine the repairs needed to return the well to "beneficial use" on or before 05/24/2014 (90 day max) in an acceptable wellbore integrity condition. Should casing repairs be prudent, submit a BLM notice of intent for approval of those repairs.

- Should "beneficial use" not be achieved before (NOI approval date + six months) submit for BLM approval a plan for plug and abandonment.
