- 3) Treat for conditions.
- 4) RBIH with ESP and production tubing.
- 5) RD x MO x clean location.
- 6) Turn well over to production.

Note: During this procedure, Oxy plans to use a closed-loop system with steel tanks and haul contents to the required disposal facility per OCD Rule 19.15.17.
