1/08/2008 Log PBTD to 3000' - TOC @ 3152'. Perf Blinbry @ 5594-98', 5688-92', 5728-34', 5810-18', 28-32' w/2 SPF, 57 holes.
1/09/2008 Acidize Blinbry w/3000 gal HCL.
1/10/2008 Frac Blinbry w/35,998 gal SS-25; 82,000# 20-40 SLC, flush w/2087 gal linear gel.
1/11/2008 Kill well, RIH w/NC & tbg.
1/14/2008 Tag sand @ 6620'. CO sand to PBTD @ 6712'; circ clean. Swab
1/15/2008 Swab
1/16/2008 RIH w/2-3/8" tbg. Hot water tbg.
1/17/2008 RIH w/prod tbg - SN @ 5977'.
1/18/2008 Open well to battery.
1/21/2008 RIH w/rods & pump. POP

NOTE: This well has been shut in as of 9/17/2013 to update paperwork and devise a plan of action to bring well into compliance.

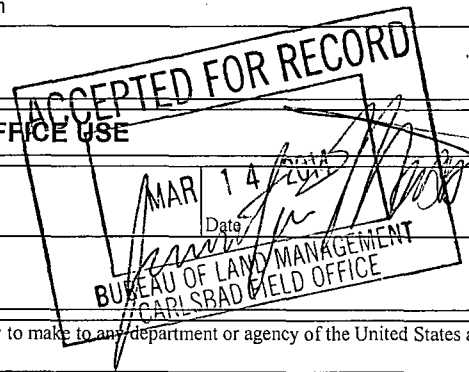
