8/13/13 RIH and set 7" CIBP at 7200'. Dump (9 sx) Class H cement on top.
8/14/13 RIH and Tag cement at 7177' PBTD.
8/15/13 RIH and perforate from 5955 to 7070', 0.39", 2640 holes.
8/16/13 RIH w/ 7" Baker Hornet Injection packer and 3-1/2" IPC injection tubing. Packer set at 5885'.
Ran MIT pre-test to 500 psi. Test good. Notify BLM and NMOCD to schedule test.
8/19/13 Perform MIT test to 525 psi for 40 minutes. Test good. Test witnessed by BLM. No agent from NMOCD on location. Original chart delivered to NMOCD - Hobbs. Chart copies delivered to BLM.
Well ready to be placed on injection.
