

2/7/16 Perform MIT test to 550 psi for 30 minutes. Test good.
Test witnessed by OCD.
Returned well to injection.

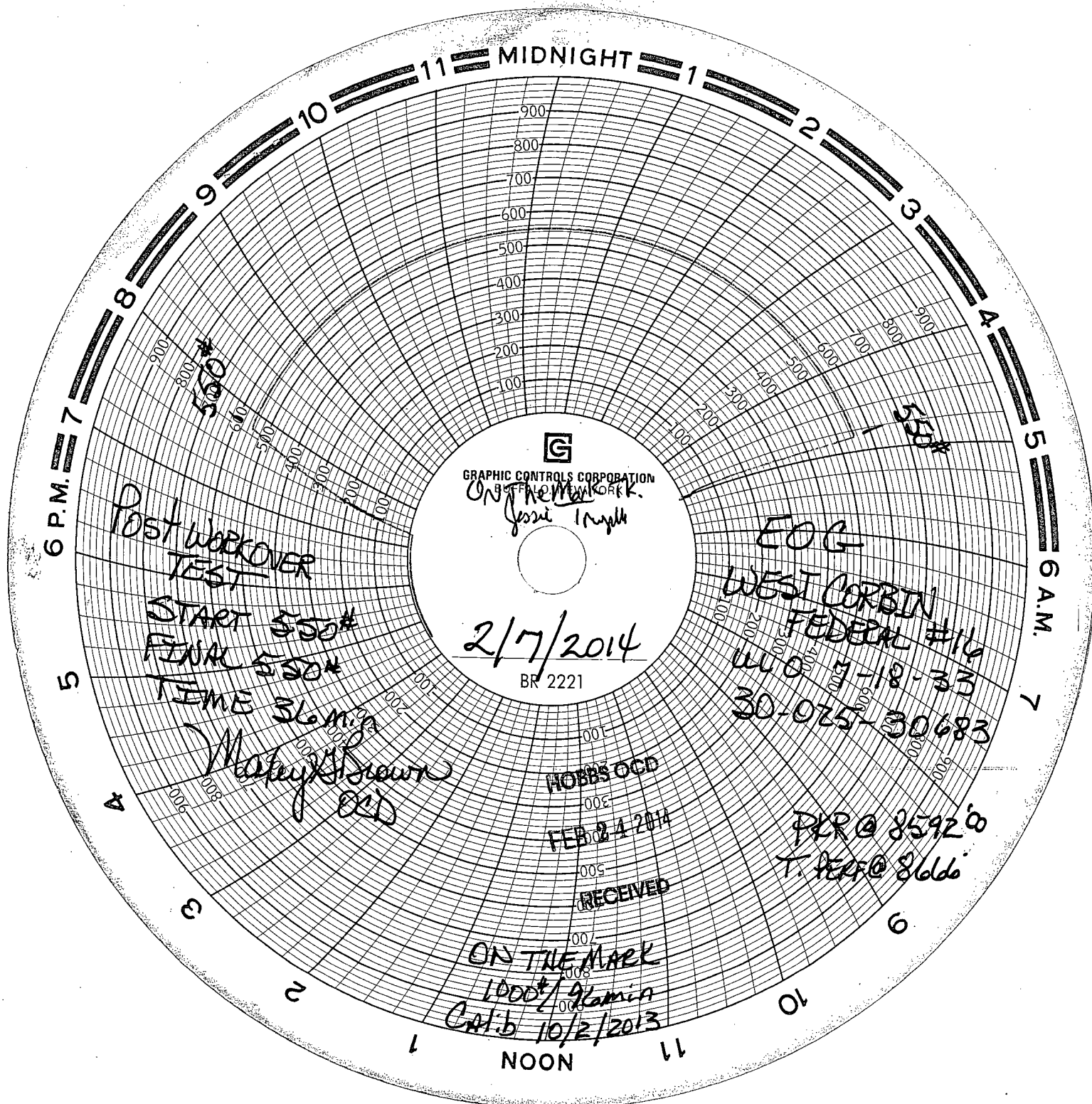
