**LETTER OF VIOLATION**

Dear Operator;

Oil Conversation Division (OCD) well files indicate that you have 19 well(s) that have been plugged for more than one (1) year without sites being released. The well(s) are listed on the Attachment enclosed..

OCD rule 19.15.25.10.d NMAC requires an operator to restore the well site as soon as practical but no later than one (1) year after the completion of the plugging operations. Within thirty (30) days after restoring the well site the operators must file a form C-103 to report that the work has been completed. Rule 19.15.25.11 NMAC.

Within thirty (30) days of the date of this letter please clean the well site(s) according to the requirements set out in 19.15.25.10.D NMAC, and file a final sundry C-103 Subsequent Report of Well Plugging (available on OCD Online under "Forms") for each well to notify the district office that the site(s) are ready for inspection and release.

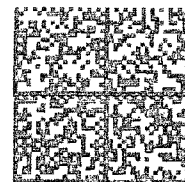
