4/15/2014 Tagged up at 2979'. POOH and picked up bit. RIH and attempt to wash down. Made no progress. POOH with bit and RIH open ended circulated MLF and spotted 25 sx class c cement. SION.

4/16/2014 RIH and tagged cement at 2838'. POOH and perforated at 1850'. Picked up packer and pressured up to 550# and held for 15 minutes. Released packer and POOH. RIH open ended and spotted 25 sx cement at 1917'. WOC and tagged at 1775'. POOH and perforated at 200'. Established circulation and attempted to circulated cement down 7" casing to perfs @ 200' and up annulus to surface. Pumped 145 sx. No cement to surface.

4/17/2014 Rigged down. Cur off wellhead. One inched annulus to surface. Took 15 sx cement. Installed marker and cut off anchors.
