4-18-14 Made up 5.5" cement retainer, ran in hole, and set @3105'. Pumped 90 bbls of lead cement @ 3bpm, 650 psi, and pumped 28 bbls of lead cement and 20 bbls of tail cement @ 2.7 bpm, 500 psi. Did not see cement on surface

4-22-14 Rigged up power swivel began drilling on cement @ 3118', and cement fell out @ 3212'. Ran down to 3341' and circulated well clean. Pressure tested casing to 500 psi lost 20 psi in 30 minutes. The casing was retested to 500 psi and held for 30 minutes, which was successful.
