7/1/2014: A kill truck equipped with a chart recorder was attached to the casing valve on this well and the 5 1/2" X 2 7/8" annulus was pressured up to 679 psi. The pressure was monitored for 15 minutes with 4 psi drop to 675 psi. The recorded chart is attached.

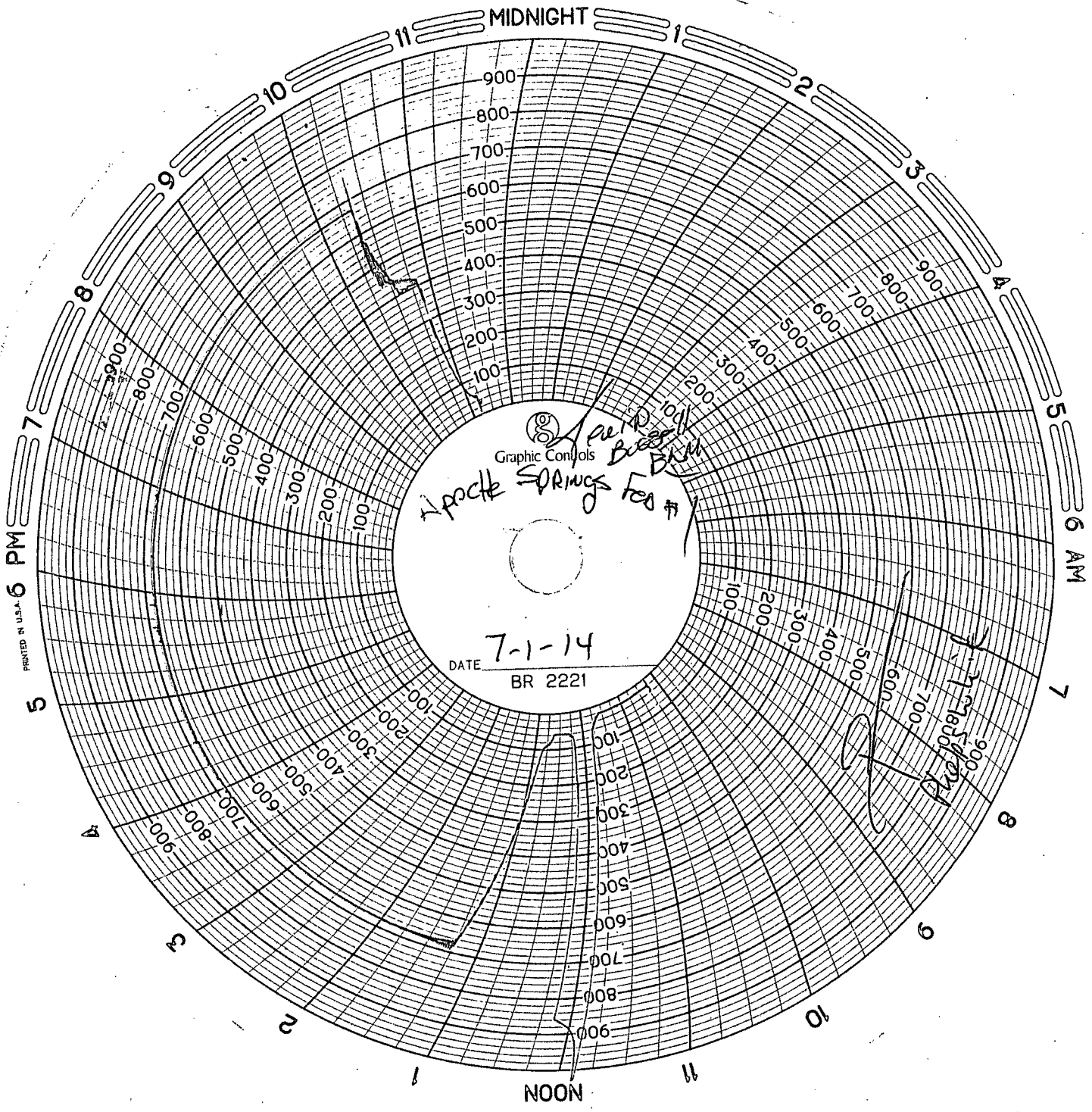
