Pursuant to the BLM letter dated June 9 2014 and received by McClellan Oil Corporation on June 11, 2014 concerning paying quantities of the subject well, please be advised the operator is proposing to abandon Morrow perforations 10,668-10,680 with a 10k rated CIBP set at 10,655 and dump bail 2 sx cmt on top. Existing Morrow perforations 10,584-96 & 10,606-08 will be reperforated, stimulated, and flow tested.

An AFE is being prepared to circulate to partners and per the operating agreement the working interest owners have 30 days to elect to participate. Based upon joint interest operations, the difficulty in scheduling of field services, and the amount of time already spent reviewing records and options for restoration of production, McClellan Oil Corporation respectfully requests an extension of time for initiating field operations from 60 days after the receipt of the BLM letter to 120 days after the receipt of the BLM letter.
