11/27-12/11/13 Drill 7.875" slant hole to 8725'MD/8157'TVD. Drill 7.875" curve to 9197'MD/8361'TVD. Drill 7.875" lateral to 12339'MD/8301'TVD. TD lateral @ 7:30am on 12/11/13 (TD lateral early due to degrading hole conditions)

12/11-17/2013 Fish for stuck drill pipe & condition hole. Run 279jts of 5.5" 17.0#/ft HCP-110 LTC casing to setting depth of 12337'MD with DV tool set @ 8625'MD. Rig up Halliburton and cement Stage 1 with 100sx EconoCem-HLH w/0.3% CFR-3 + 5% salt + 5#/sk KolSeal + 0.125#/sk Poly-E-Flake + 0.35% HR-601 (weight=12.7#/gl, yield=1.99cf/sk, Mixed @ 10.47gl/sk) & tail in with 700sx VersaCem-H w/0.5% Halad-344 + 0.3% CFR-3 + 1#/sk salt + 0.1% HR-601 (weight=14.4#/gl, Yield=1.23cf/sk, mixed @ 5.5#/gl). Drop bomb & open DV Tool, circulate cement off of DV Tool (56sx/25bbls cement to surface. Cement 2nd stage w/1200sx EconCem-H w/0.5% Halad-322 + 5#/sk KolSeal + 0.125#/sk Poly-E-Flake + 0.25# D-Air 5000 (weight=12.7#/gl, yield=2.49cf/sk, mixed @ 13.8gl/sk) & tail in with 100sx VersaCem-H Neat (weight=16.4#/gl, Yield=1.07cf/sk, mixed @ 4.5#/gl). Plug down @ 12:24am on 12/17/14. Circulated 169sx (75bbls) to surface.
