Stage 2 (11508'-11852') w/209,272# sand & 164,430gl
Stage 3 (11070'-11402') w/213,923# sand & 160,155gl
Stage 4 (10008'-10340') w/313,856# sand & 220,247gl
Stage 5 (9150'-9310') w/712,522# sand & 417,052gls

2/17-20/14 Drill out CBPs & cleanout hole to 12275'MD

3/4/14 Run tubing & ESP w/ESP intake set @ 8292'MD & put on production

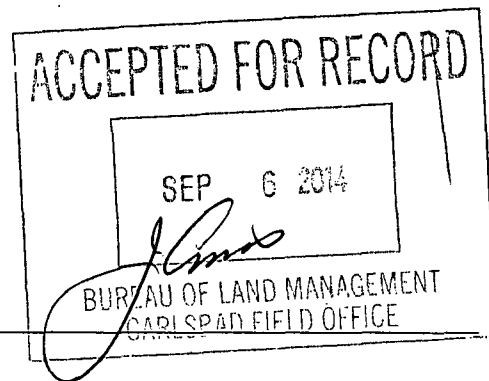
3/9/14 First oil production on 3/9/14 @ 12 BO + 586 BW w/no gas
