Failure to comply with Rule 19.15.25.8 "Wells to be Properly Abandoned" and Rule 19.15.16.8 "Sign on Well"

Mr. Michael Novy

On April 4, 2013, the OCD notified Novy Oil & Gas Inc. ("Novy") that Novy was out of compliance with division rules 19.15.15.8 and 19.15.16.8 NMAC. Per that letter, Novy was instructed to plug & abandon or return referenced well to producing status and install a well sign. A subsequent inspection indicates neither items have been addressed.

Immediate action is now required on your part to resolve this matter. Please contact Daniel Sanchez in Santa Fe at 505-476-3493 before October 17, 2014 to discuss this matter.

If Novy fails to contact the OCD by the time specified, the matter will be referred to our legal department and a compliance hearing will be scheduled. At hearing, the OCD will seek a compliance order against Novy, requiring compliance with OCD Rules and seeking additional sanctions.

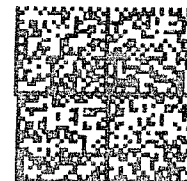

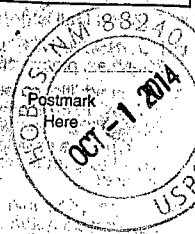
