A DRY HOLE MARKER WILL NEED TO BE CONSTRUCTED AND INSTALLED, AND CELLAR BOARDS SHOULD BE REMOVED AND FILLED IN. 1st notice.

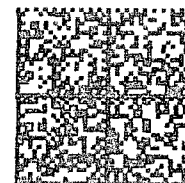
