The meter flashed and blew the fuses which resulted in a loss of power. The fault clearing caused the arc flash to self-extinguish. COPC employee called COPC Systems Specialist to inform him of the incident. I&E replaced the equipment. The NM Electrical inspector will verify the replacement and Lea County Electric will return to service. There were no injuries associated with this incident.

Describe Area Affected and Cleanup Action Taken.*

None of the area was affected by the fire. I&E replaced the equipment. The NM Electrical inspector will verify the replacement and Lea County Electric will return to service.
