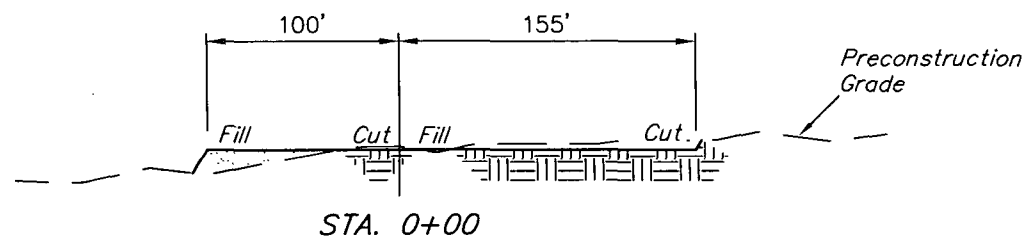
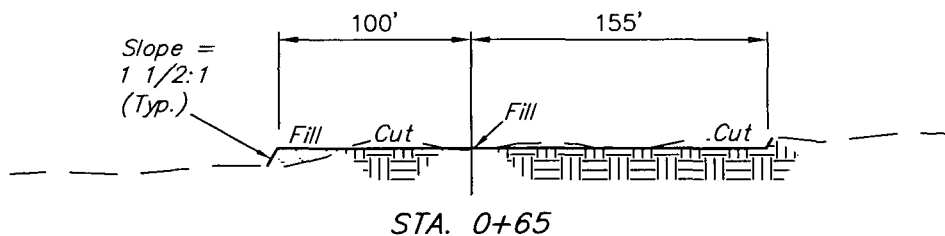
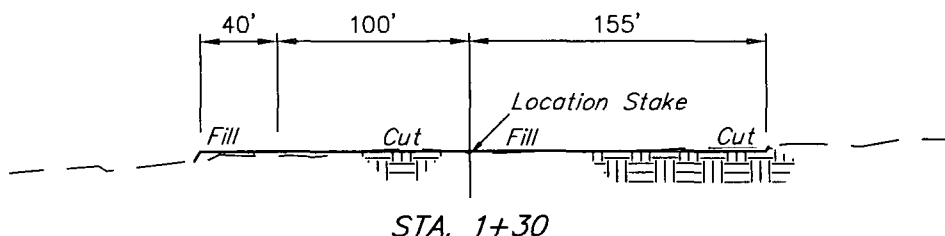
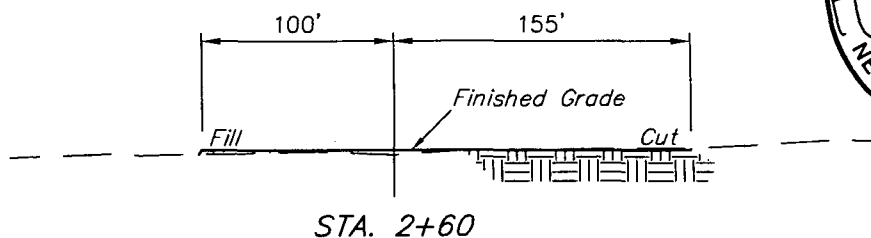
LOCATION LAYOUT

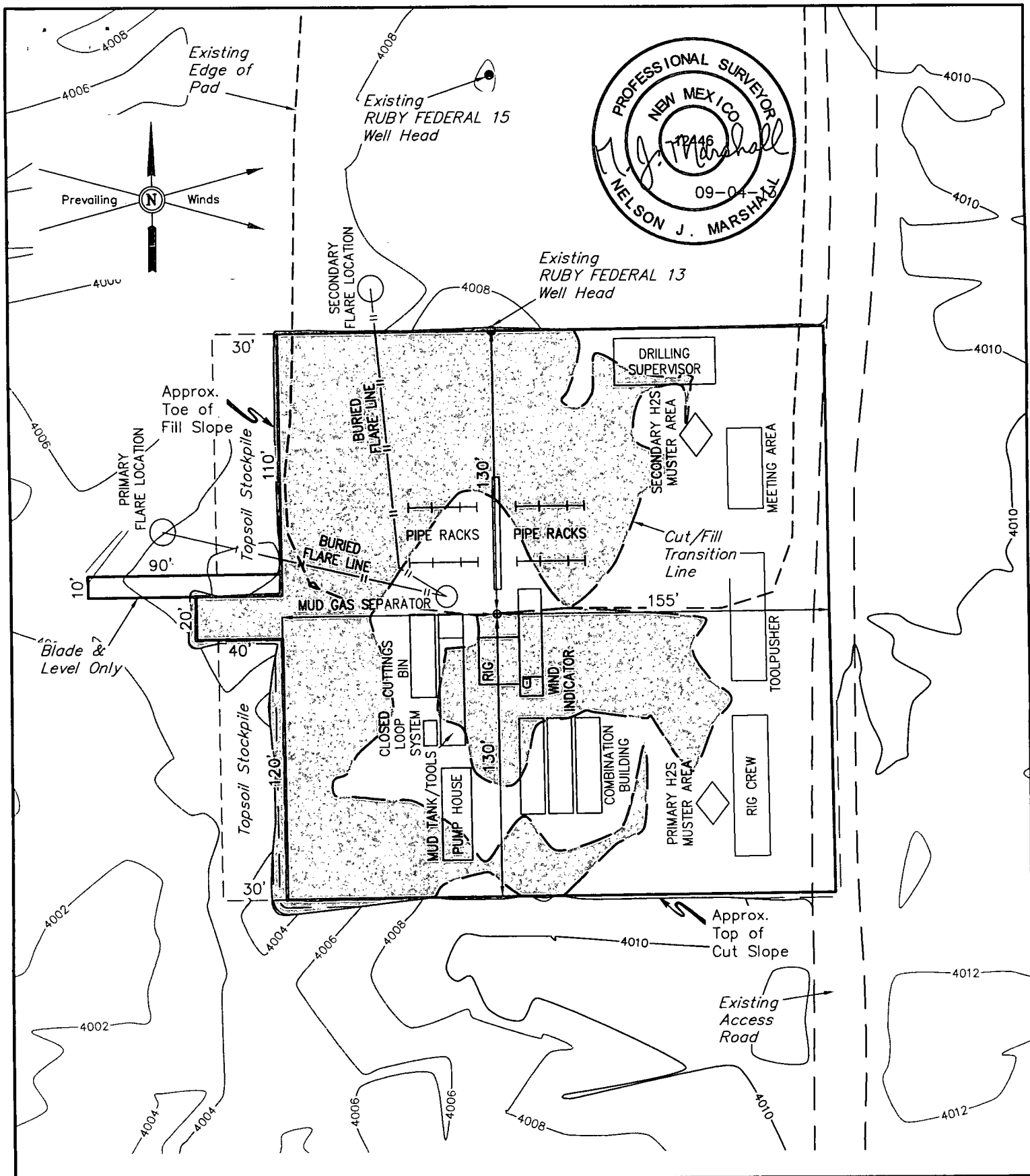

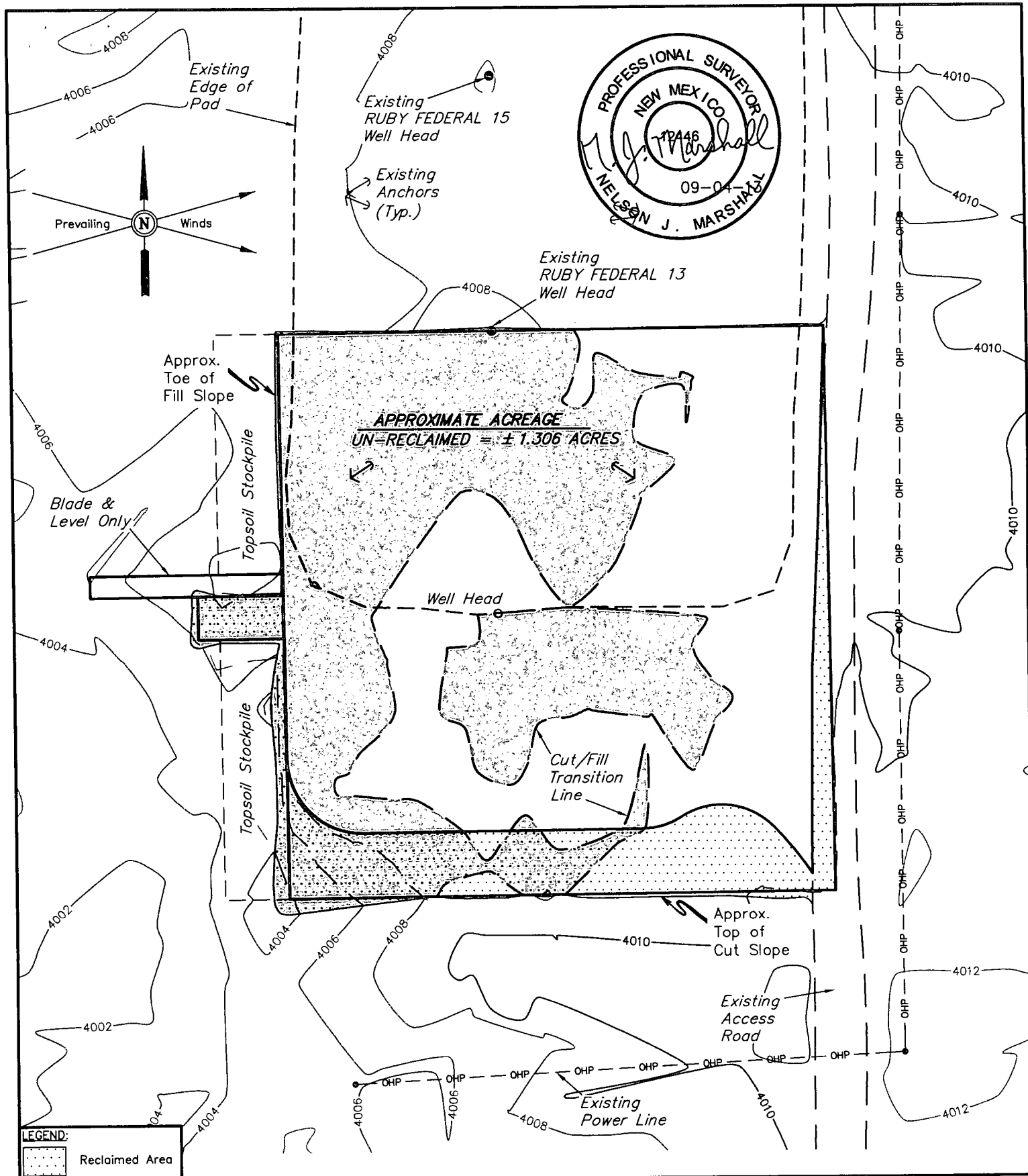

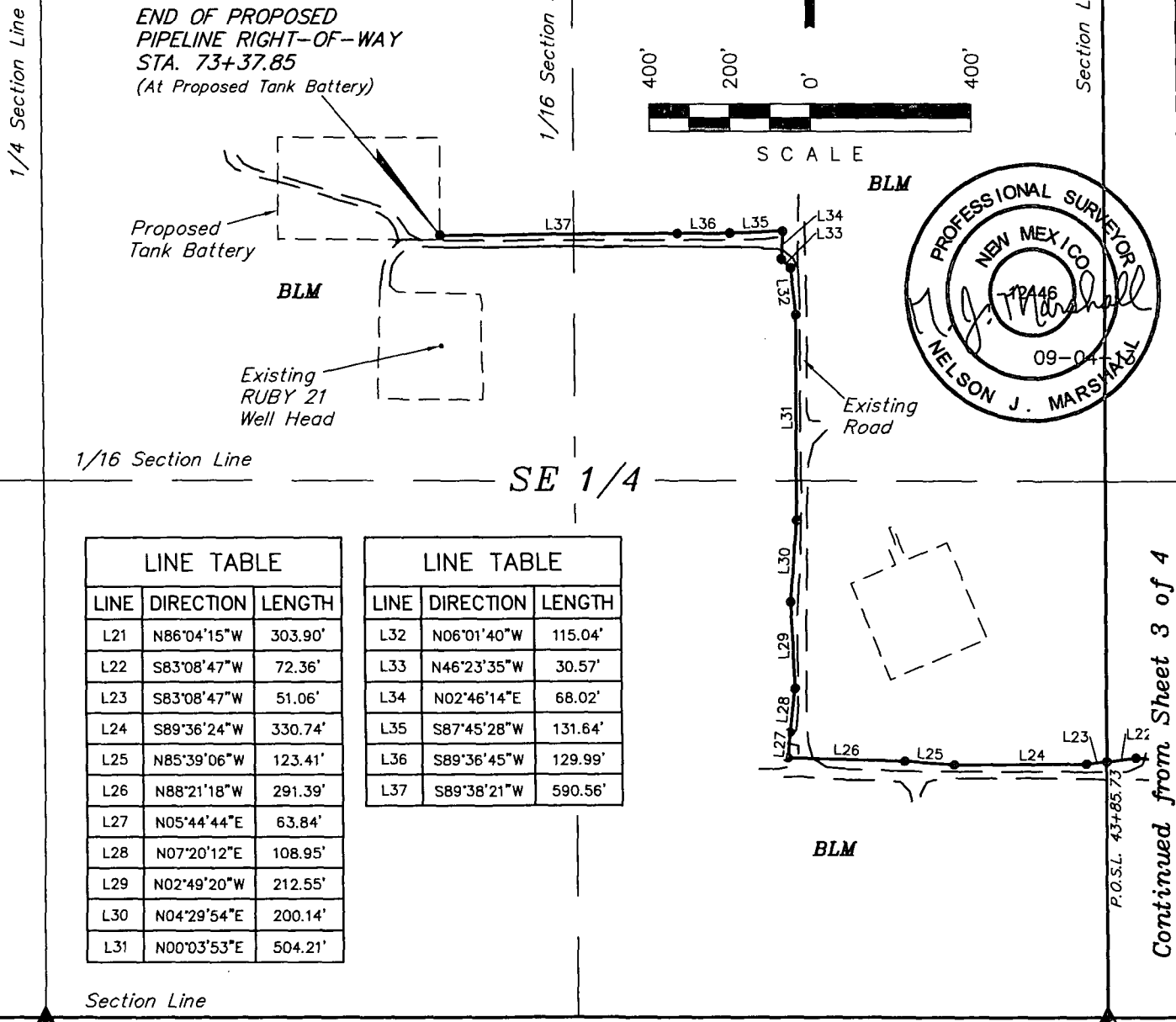

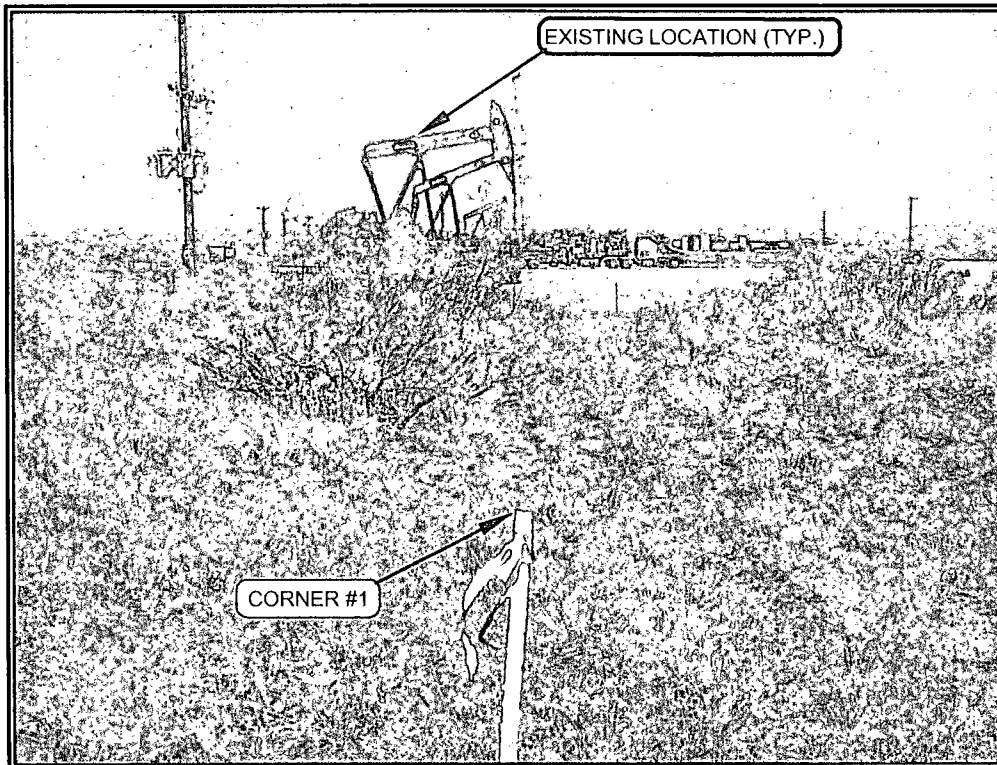

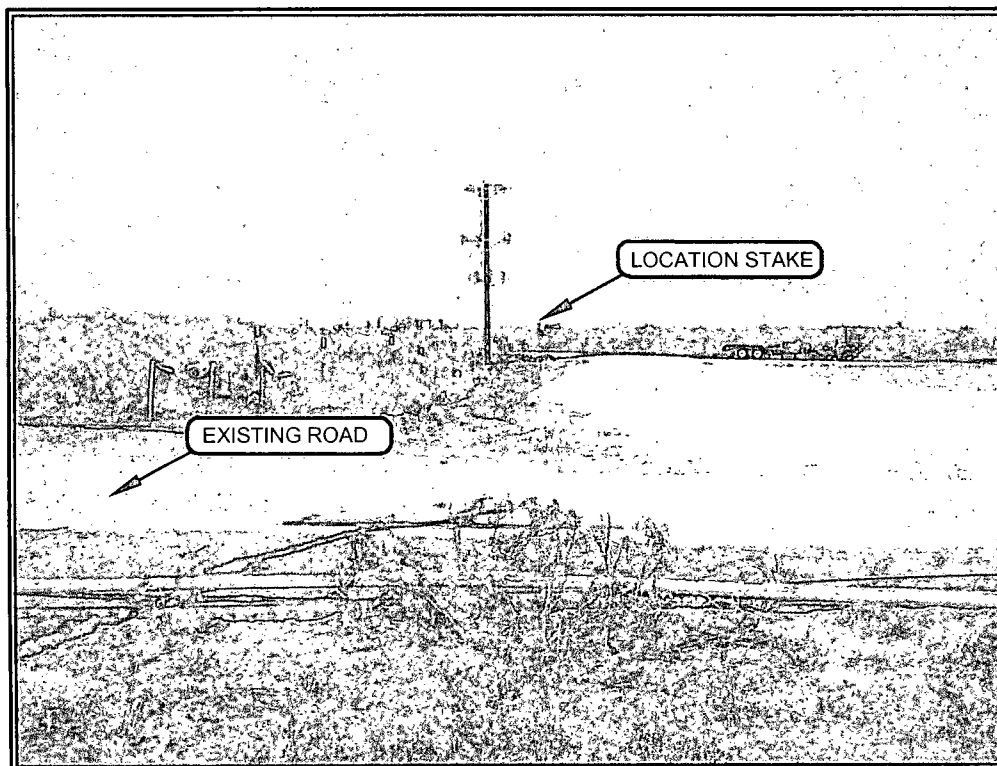



PHOTO: VIEW OF LOCATION STAKE AND EXISTING ACCESS ROAD
