Dear Operator:

The following inspection(s) of the well files indicate that the well(s) have been drilled, but the operational status of the well(s) failed to meet standards of the New Mexico Oil Conservation Division as described in the detail attachments. To comply with standards imposed by Rules and Regulations of the Division, corrective action must be taken immediately and the situations brought into compliance.

Rule 19.15.16 states that completion forms must be filed within 20 days after completion of the well. Per each attachment is a list of what is required for each well.

Please Note: Delay in processing of regulatory forms may result in operator receiving production and dispositions error messages generated by C-115 reporting.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due" by January 30, 2015, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon these wells.
