ConocoPhillips Company request permission to reroute and upgrade a flowline from the MCA 47 (located in the SWNW of Section 21, T17S, R32E) to the MCA 2D Header (located in the NESW of Section 21, T17S, R32E).

The new pipeline will be a 2 1/2" Fiberspar surface pipeline approximately 2,815ft in length. The pipeline will have an operating pressure of approximately 70 PSI with a flowrate of 97 BPD (oil, gas, & water mixture).

The pipeline route will follow existing road corridors to keep surface disturbance to a minimum. The new pipeline route will also assist ConocoPhillips Company personnel in detecting possible leaks on the pipeline as soon as they occur.

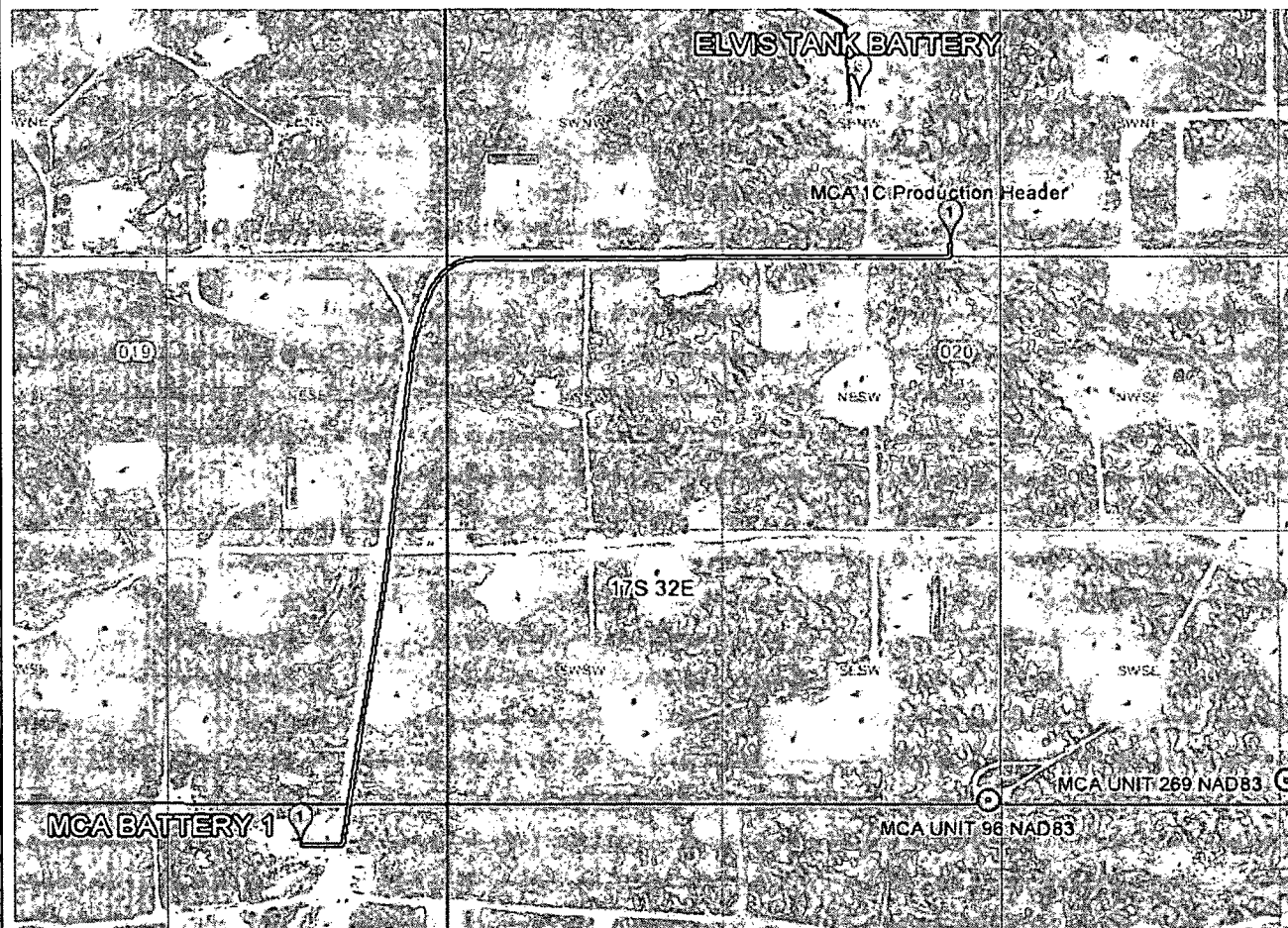
