The gas line will become the flowline & the water line will become the return gas line from the battery to the well for gas lift purposes. This will allow for more interim reclamation. Closed Loop Pad Dimensions 280' x 320'

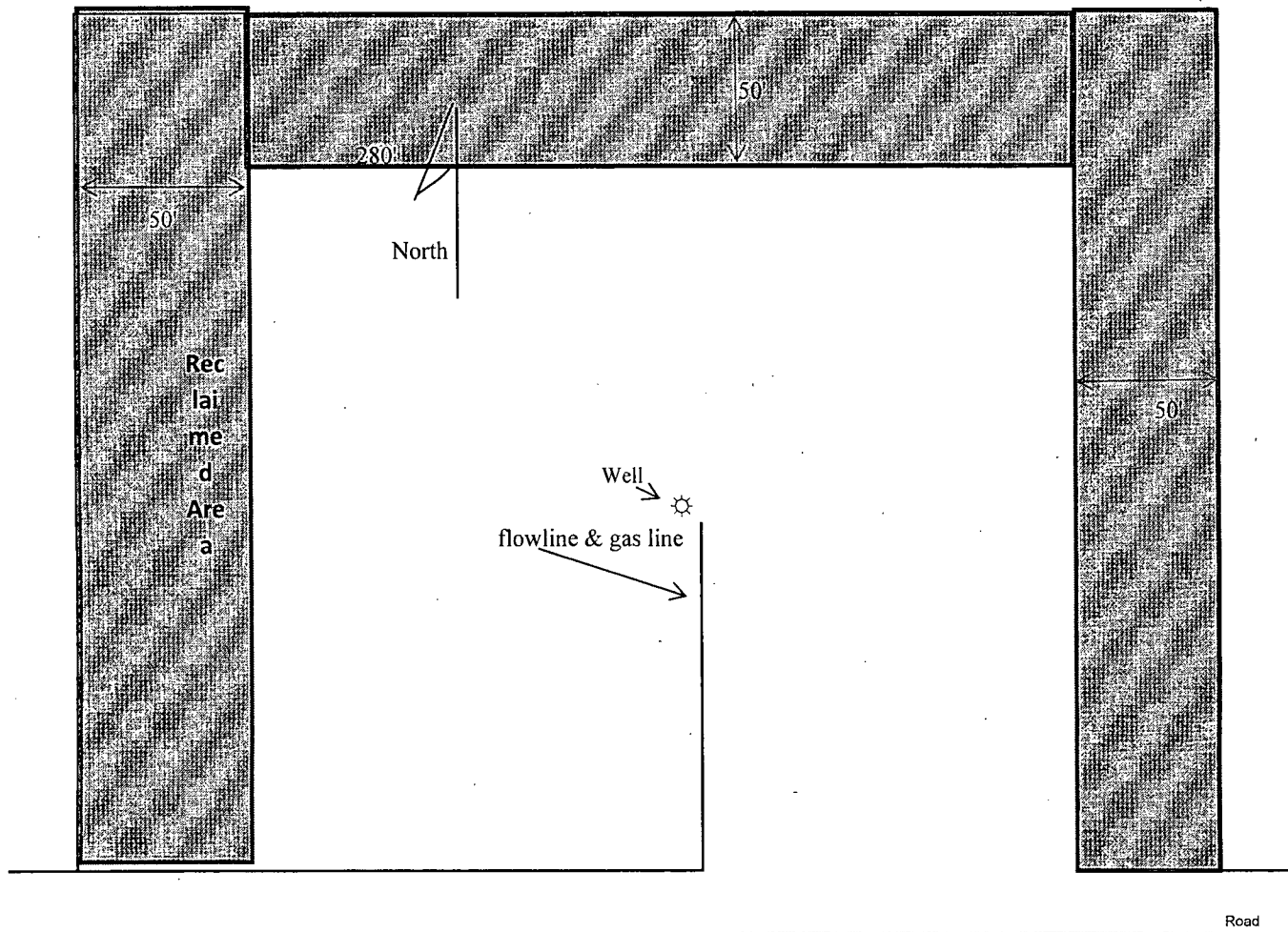
