Operator will drill 8-3/4? to the end of curve.
Operator will reduce hole size down to 7-7/8? and drill the lateral to TD.
Operator will pump the following production cement job:
Lead: 1300 sx of 50:50:10 H blend (11.9 ppg ? 2.51 cf/ft)
Tail: 1025 sx of 50:50:2 H blend (14.4 ppg ? 1.24 cf/ft)
