- 1) MIRU pulling unit. Flange down injection wellhead. Install BOP.
- 2) POH with inj packer and inj tubing. RIH with 3 7/8" bit and cleanout suspected casing bridges and wellbore. Fill to 5488' PBTD (CIBP @ 5488')
- 3) Spot 275 gal 15% NEFE HCL across perfs 5361'-5478'. RIH with 4 1/2" packer. Acidize perfs with 5000 gal 15% NEFE HCL.
- 4) Flow back well until dead.
- 5) RIH with new inj packer and current IPC tubing and on/off tool. Set packer at 5082'.
- 6) Notify BLM and run MIT casing pressure test to 500# for 30 min.
- 7) Return well to active injection.
