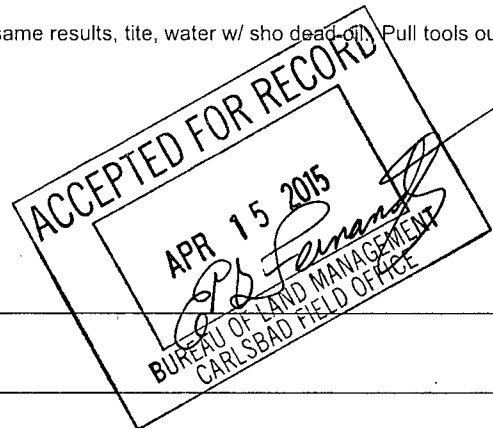
8/25/14: Run CBL log and perforate 5088-5108 and 5116-5121 w/ 1 SPF, 8/26/14: Acidize perforations w/ 2500 gals 15% NEFE. 8/27/14: Swab test perforations with very little fluid entry with slight show of dead oil.

9/8/14: Perforate 4934-56, 1 SPF, 4976-80 and 4990-98, 2 SPF. Plug off bottom perforations with RBP @ 5053'. 9/9/14: Acidize perforations w/ 5000 gals 15% NEFE and swab load. 9/10/14: Swab test perforations, Swab testing indicates a commercial well, est 40 bopd.

9/11/14: Unset RBP and set packer at 5053' and re-swabbed perforations from 5088-5121 with same results, tite, water w/ sho dead oil. Pull tools out of hole

9/12 - 9/13/14: Run Production tubing and rods. Waiting on Pumping Unit.
