10-15-2014, RIH w/packer and tbg. set packer @ 2849' acidize with 2000 gal's of 15% HCL acid. unset packer POOH, laid down 3 1/2' tbg. S/I.

10-16-15, RIH w/ 7" as IX nickel plated packer, (2.81 f) on/off tool, and 66 jts of 4 1/4 IPC csg. Production pipe; circulate packer fluid, set packer @ 2849' (86' on top of top perms) tst csg to 500# for 30 min. Held okay.

10-17-2015 Perform a 30 min MIT test to 350#, witnessed by OCD officer. Test Pass OK. Rig down - moved out, cleaned up location.
