Ran 61 jts 13 3/8" 61# J-55 casing equipped with Float Shoe, Float Collar and 6 centralizers, landed casing @ 2187'. Casing was cemented with 1310 sx Class C +.005ls/sx SF+2%CaCl+.13lb/sx CF+5lbs/sx and 250 sx Class C+.006 lbs/sx SF+1%CaCl. Circulated 645 sx to surface, plug down 2:15 pm 11/18/2014.

Installed and tested Annular BOP and commenced drilling a 12 1/4" hole at 8:00 pm 11/19/2014. TD 12 1/4" hole at 6:30 am 11/23/2014

Run 128 jts 9 5/8" 40# N and J 55 casing equipped with float shoe, float collar and 5 centralizers. Shoe landed at 4977'. Casing was cemented with 895 sx 35:65:6 Class C + Additives and 250 sx Class C Neat. Circulateed 156 sx to surface and landed plug at 12:56 am, 11/24/2014.

Installed and tested Double Ram BOP, Hydrill and roatating head. Tested BOP and commenced drilling at 7 7/8" hole at 11:45 pm 11/24/2014.
