11-04-2011: Squeeze existing Blinebry perfs 5,820' - 6,332' w/300 sacks of Class H cement.

11-07-2011: POOH w/packer. RIH w/bit and drill out squeeze cement from 5,780' - 6,335'. Pressure test casing and squeezed-off Blinebry perfs to 1,500# for 15 mins. successfully. TOO H w/bit & LD same. TIH w/retrieving head and latch onto RBP, POOH w/same.

11-08-2011: RIH w/single tubing string, ND BOP and NU wellhead. RIH w/pump and rods.

11-09-2011: Hook up wellhead to flowline and return well to production.

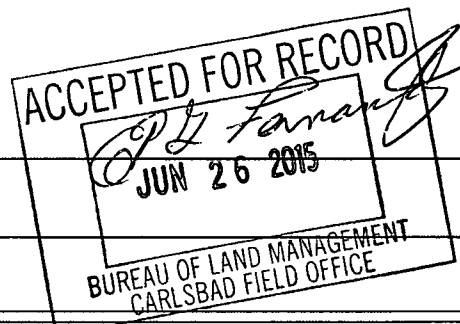
