7/8/15 - Directionally drill 8-3/4" production hole to 5010' (TMD).

7/8/15 -

7/9/15: Rig up CRT x run 128 jts 7", 26#, J-55, LT&C casing with 68 centralizers and set at 5000'. RU Halliburton and cement first stage with 250 sx. 14.8 ppg, Cl. C. Bump plug and open DV tool (at 4120'-4124') x circulate 123 sx. to surface. Cement second stage with 380 sx. 11.9 ppg, Cl. C (lead) and 230 sx. 14.2 ppg, Cl. C (tail). Circulate 76 sx. to surface. Set x tested casing pack-off to 3000 psi x ND BOP equipment. NU wellhead and test to 3000 psi. Jet pits x rig down.

Release drilling rig (H&P 340) at 11:59 p.m., 7/9/15.
